



Charitable Request Form

Sprague strives to be a good corporate citizen throughout the areas in which we operate, specifically focusing our contributions on programs supporting children and the environment. Eligibility

Organizations recognized as tax-exempt under Section 501(c)3 of the Internal Revenue Code are eligible to apply for support. Organizations serving the needs of children or advance environmental stewardship within Sprague's area of operations will receive priority over other requests. Sprague seeks opportunities to make contributions where a modest amount of funding can help an organization achieve a significant result. Awards typically range from \$250 to \$10,000, and the majority of awards are for less than \$5,000. Sprague receives many requests for support, and seeks the most productive uses for available funds.

When To Apply

All applications for support must be received via email or postmarked by April 1st to be considered for an award in the same calendar year. Award recipients will be notified in writing by June 1st, with awards disbursed by the end of the month. Organizations seeking support for activities occurring in the first quarter should apply for support in the preceding calendar year.
